GENERAL REQUIREMENTS

In consideration of being considered for and possibly selected to participate in the Program and for other good and valuable consideration which Participant has received, Participant must hereby acknowledge and irrevocably agree to the following terms and conditions which shall govern the participant selection process for and possible participation in (if selected), the Program:

1. All Participants must be legal U.S. residents, at least 18 years of age.
2. All Participants must be single and without any dependant children. To qualify as "single" the applicant must not currently be involved in a committed relationship, including, but may not limited to: any marital relationship (whether or not the parties are separated or currently in the process of divorcing or annulling such marriage) or any co-habitation relationship involving physical intimacy. To qualify as “without any dependant children” the applicant must not currently be legally responsible for a biological or adopted minor.
3. All Participants must never have been convicted of a felony nor ever had a restraining order entered against them.
4. All Participants must be adaptable to various living situations and must enjoy meeting and interacting with others who may be of varied backgrounds and experience.
5. All Participants must be willing to accurately and completely fill out an extensive background questionnaire and undergo investigations into their background, which may include reviews of civil and criminal records, financial, credit, health, employment history, emotional, physical and psychological screenings, and any other type of background checks deemed necessary by Magical Elves, Inc.

("Producer") and/or the applicable broadcast network of the Program ("Network"), and must sign all necessary consents and releases in connection therewith.

6. All Participants consent to Producer conducting a thorough background investigation which may include obtaining information about Participants from governmental organizations and contacting those individuals, employers, or references provided by Participants reasonably related to the information provided by Participants, as determined by the Producer and/or Network in their sole discretion, in connection with this questionnaire, and the selection process in general, to verify the information provided by or relating to Participants and those individuals may be requested to give an opinion regarding the applicable Participant's character.
7. Participant agrees to undergo physical and psychological examinations conducted by medical personnel of Producer's choosing, and acknowledges that they may be disqualified at any time in Producer's and/or Network's sole and absolute discretion.
8. If chosen to participate on the Program, all Participants, their families and close friends must be willing and available to participate and be filmed in the Program for a one year period in 2008-2009 on dates to be determined by Producer, and, if necessary, to allow filming at their home, place of employment and any other location to be determined by Producer. Participants agree to exercise best efforts in obtaining the cooperation of their family and close friends in connection with the foregoing. Additionally, Participants must be available to participate in publicity, promotion, advertising and marketing of the Program and Network. Dates and/or location to be determined and subject to change in Producer's and Network's sole discretions.
9. All Participants must be available to travel to Los Angeles for further interviews. Locations and dates of such interviews will be determined and are subject to change in Producer's and/or Network's sole discretion. If Producer requires Participant to travel more than 200 miles from Participant's primary residence in connection with such interviews Producer acknowledges that it shall provide or reimburse Participant for approved related transportation costs.
10. No Participant may be a candidate for public office at the time of application. If a Participant is chosen to participate on the Program, Participant agrees not to become a candidate for public office for a one-year period following the initial broadcast of the final episode on which Participant may appear.
11. Commencing upon submission of an application for the Program, Participant may not be a contestant or a participant on any reality television show until one (1) year from the date of the broadcast of the Program's final episode of the season. If any potential Participant is currently being considered as a contestant and/or participant in a primetime television reality/game show, he/she must withdraw his/her application from such competing show upon Producer's request.
12. Employees, shareholders, officers, directors, agents, representatives, and their immediate family members (including those living in the same household,

whether related or not) of Magical Elves, Inc., production personnel for the television program tentatively entitled "Arranged Marriage" or any other television program produced by Magical Elves, Inc. or associated with the applicable broadcast network of the Program, participating television stations or advertising agencies, or any of their respective parent companies, affiliates, subsidiaries, agents or representatives are not eligible.

13. All Participants agree that if they are selected to participate in the Program they will not engage in any activity or exhibit behavior that would adversely affect the Program, Producer or the Network, as determined in the sole discretion of Producer and Network, and that they may be disqualified at any time in Producer's and/or Network's sole and absolute discretion.
14. All Participants must agree to sign any additional releases or authorizations that Producer and/or Network, in their sole discretions, deem necessary.
15. During the production of the Program all Participants agree to participate in good faith in any counseling and/or therapy sessions requested by Producer.
16. All Participants agree that this application form and any other materials (including, but not limited to, photographs, recordings, drawings, songs and videotapes) Participant may have submitted or will submit to Producer will become the sole property of Producer and Network and will not be returned. Participant agrees to grant rights to Producer and Network to use any biographical information contained in this application, Participant's home video or taped interview, and to record, use, and publicize Participant's home videotape or taped interview, voice, actions, likeness and appearance in any manner in connection with the Program or Network.
17. Producer and/or Network may edit, alter or modify any materials provided by Participant, it being understood that Participant agrees to release and hold harmless and indemnify Producer and Network in connection with their exploitation of such modified materials.
18. **Participant hereby agrees to release and hold harmless and indemnify Producer and Network, including without limitation their agents, representatives, licensees and assigns (collectively referred to as "Production Entities"), from all claims, demands, causes of actions, damages, and other liabilities of any kind, including, without limitation, reasonable attorneys' fees and costs which may arise out of, or in connection with materials and any information provided by Participant or on Participant's behalf to Producer and/or Network, Producer's false certification of such information, or otherwise related to the application process and the Program. Participant further agrees to indemnify Producer, Network and the Production Entities and their respective employees, officers, directors, shareholders, successors, licensees, assigns and affiliated entities harmless from and against, any and all payments required by collective bargaining, guild and union agreements.**

Participant agrees that no sum or other compensation of any kind, now or in the future, shall be due to Participant or any third party for the execution of this General Requirements and Casting Application.

Producer and Network reserve the right to add to, change, modify or delete any of the eligibility requirements, as well as to add additional requirements not listed herein, at any time including but not limited to the time before, during and after the selection process in its sole discretion. Producer and Network also reserve the right to modify the manner in which it produces the Program, or to not produce the Program at all.

All information and materials related to the Program received or acquired by Participant during the selection process shall be held strictly confidential, and Participant shall not disclose or otherwise disseminate any such information to any third party.
